Article 4. OFFICERS AND ELIGIBILITY FOR OFFICE

Paragraph 5

Current:

If for any reason a person can not finish the term of office he/she was elected for, then the following procedure shall apply;

If the Chairman, then the Vice-Chairman shall serve as Chairman.

If the Vice-Chairman, then the Chairman and Secretary/Treasurer shall share the duties.

If the Secretary/Treasurer, then the Chairman and Vice-Chairman shall share the duties.

Proposed Change:

If for any reason a person cannot finish the term of office he/she was elected for, then the following procedure shall apply;

If the Chairman, then the Vice-Chairman shall serve as Chairman.

If the Vice-Chairman, then the remaining Board members may share the duties or choose a replacement to fill the remainder of the existing term of office.

If the Secretary or Treasurer, then the remaining Board members may share the duties or choose a replacement to fill the remainder of the existing term of office.

Advantages: This will give the sitting Board the choice of taking over the job of the absent member or choosing someone else to fill the position.
